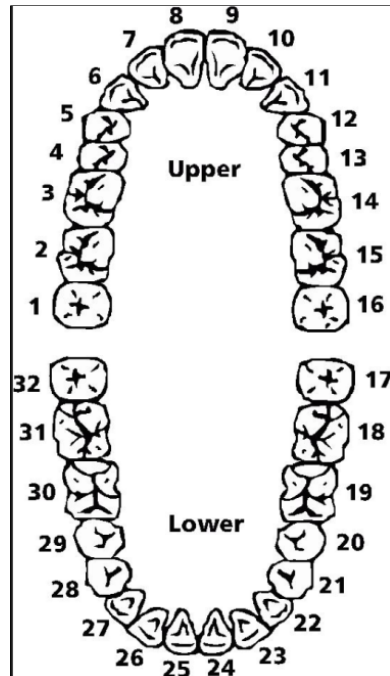
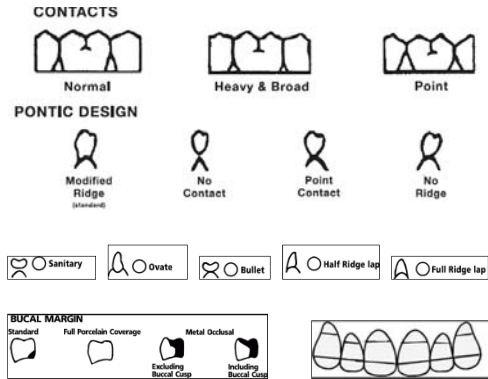

No oral representations or instructions will be accepted in lieu of written scripts.

Financial Obligation:

All statements must be paid by the 10th of the month in which the statement is sent. Interest incurred will be 1.5% finance charge and the account will automatically be placed on C.O.D. Invoices sent with a case will be billed and payable in stages of cases. Premiere 1 Dental Laboratory, LLC will retain all cases and or items sent as its property until the account is paid in full. All returned checks will be charged a minimum of \$50.00 per occurrence. All disputes shall be governed by Maryland laws with venue in Baltimore City. The prevailing party will recover all fees and expenses related to the case.

What is Covered?

Repair or replacement of appropriate dental appliance.

What is not Covered?

Not responsible for any fixed or removable prosthesis that has not been tried in and fitted before final approval process.

Not Responsible for any appliances that have been fabricated either partially or fully by another dental lab other than Premiere 1 Dental Laboratory, LLC.

Not Responsible for repairs caused from accidents, improper adjustments or lack of dental hygiene. Nor any additional problems such as bone loss or failure of other oral supportive structures, or surgery.

Not Responsible for cash refunds or any costs associated with insertion or removal.

Not Responsible for replacement denture or correction after temporary or immediate denture.

Warranty is for one year from delivery date, warranty is in lieu of all other warranties, expressed or implied and may not be altered or modified by any employee, representative or agent of Premiere 1 Dental Laboratory, LLC.
